Tournament Format Summery

Competition will start on	Monday 11th October 2021
League stages will finish by	Sunday 28th November 2021
Knockout stages will begin on	Saturday 27th November 2021
Competition will finish by	Sunday 19th December 2021
Matches	2 x 21 aces and tiebreak of 11 if necessary
Points	Three points for a 2-0 win otherwise 2-1 if the tie goes to a tiebreaker
Timeouts	3 x 60-second duration per player per 21 game, 2 x 60 second duration per player per 11 game
Qualifiers for semi finals	Top 4 in groups of 5 or more
Qualifiers for finals	Top 2 in groups or 4 or less
Results	Text to 087-2060715 on the night to the match or first thing the following morning
Scores	With scoring averages possibly used to avoid playoffs when players finish level on points (when head-to-head results are unable to separate them) at the end of the league stages, accurate scores should be submitted with results. To avoid a problem afterwards players should agree the scores to be texted in.

Walkovers in the League

A player can concede one walkover in the league without having to withdraw, but this cannot be in either his/her first or last match. A player so doing will be deemed to have withdrawn from the competition. A player conceding a walkover (through his/her club secretary) must do so by 1pm on the day of the match (at the latest) otherwise a one-point penalty reduction will apply. If the player has no points, a minus -1 will apply.

Playing Attire

In line with Wexford GAA Handball RULE 112 all players must wear their official club jersey and shorts. Failure to comply may result in loss of points.

Procedures and Policies for Fixtures, Postponements & Changes

All players should be aware that any requests regarding fixtures, postponements or changes must be submitted through the club secretary to the secretary of the County Competitions Control Committee (CCCC). The full rules and regulations governing the league are available for viewing on our website under County 4-Wall League Rules & Regulations and this should be read by all those taking part.

- Withdrawals (a)** When a player withdraws without playing, all others in the group will be deemed to have won 2-0 against him/her
- Withdrawals (b)** When a player withdraws having played at least one game that result will stand, but all remaining games are deemed to have been lost 0-21, 0-21
- Walkovers** A player receiving a walkover will be deemed to have won 21-0, 21-0 – a player conceding a walkover will be deemed to have lost 0-21, 0-21
