Qualification Group winner will qualify for the final. 2nd and 3rd will meet in a semi-final.

Scoring 2 x 21 aces, with tie break to 11 if necessary.

Timeouts 3 x 1 minute in game of 21, 2 x 1 minute in game of 11

Balls Adult ball - Groups 1-19 inclusive

Dark Blue ball - Group 20

Points 3pts for 2-0 win otherwise 2-1 if the match goes to a tiebreak

Players finishing level on points Head-to-head result will decide the placings. If three or more players finish level and the head-to-head cannot

separate them, the highest average FOR score (per game) between those who have finished level on points will be

used to decide. If still level, the lowest average AGAINST score (per game) will determine the placings.

Walkover option A player can concede one walkover in the league without having to withdraw, but this cannot be in his/her last

match. A player so doing will be deemed to have withdrawn from the competition.

Unavailable dates Players may submit unavailable dates, but these SHOULD NOT be taken as guaranteeing facilitation.

Requests (through club secretary) Requests for postponements made after the fixtures have been released are unlikely to be facilitated and the

walkover option is available to those players.

Withdrawals without playing All others in the group will be deemed to have won 21-0, 21-0 against him/her Withdrawals after 1 game The result will be discarded and all games will be deemed lost 0-21, 0-21

Playing Attire In line with Rule 10, CLG Liathróid Láimhe Constitution all players must wear their official club jersey and shorts.

Penalties are €70.00 for a first offence and €100.00 for any subsequent offence/s by the same player/team.

Results Including <u>walkovers</u> must be sent via WhatsApp to 087-2060715 on the night of the match or first thing the

following morning. No late results will be accepted and 0-0 will be entered on the league table in that event.

Scores accuracy With scoring aggregates possibly used to decide placings when players finish level on points, accurate scores should

be submitted with results.
