### **RULES (D1)**

**Team panels** Max six named on each club panel and these cannot be changed during the competition. Any four from six can be selected each time, (except for COG/DAT) with teams exchanged before the match starts.

**Subs** One sub from an 'outside' club is assigned to each of the two clubs who form the amalgamated team, but they can only be used by the club they are assigned to, and only in the event that they are unable to field their own two named club members. Additionally, that club must notify the CCCC in advance if they intend availing of the sub option. When a sub is used the amalgamated team must revert back to the original team members. Both subs cannot be used for the same club.
